Terms & Conditions Of Sale

- 1) **GENERAL** In these conditions the person or company who has placed an order with us is referred to as "the customer" which expression shall include any principal on whose behalf the person or company placing the order is acting as agent. The customer's order is accepted subject to these terms and conditions only which shall over-ride any terms or conditions stipulated by the customer. No variation to our terms and conditions shall be binding upon unless accepted by us in writing.
- 2) **DEFECTIVE GOODS** Goods if returned to us and accepted by us as defective will be replaced provided that the defects are notified to us in writing within 48 hours of delivery.
- 3) **ALL MONIES RETENTION OF TITLE** The risk of the goods shall pass from the company to the buyer upon delivery of such goods to the buyer. However, notwithstanding delivery and the passing of risk in the goods, title and property of the goods, including full legal and beneficial ownership, shall not pass to the buyer until the company has received in cash or cleared fund payment in full for all goods delivered to the buyer for which payment of the full price of the goods shall include the amount of any interest or sum payable under the terms of this and all other contracts between the company and the buyer under which the goods are delivered.

LIQUIDATION OR BANKRUPTCY

If at any time the customer shall commit an act of bankruptcy or, being a limited company suffer the appointment of a receiver or if a resolution for the winding up of the company or a petition therefore shall be made or presented or if there should be any assignment for the benefit of creditors, this contract may be cancelled by us wholly or in part by notice in writing but without prejudice to all existing liabilities of the customer to us.
